# **Using SFU Archives**

#### What is in the Archives?

People and organizations create, receive and keep letters, diaries, financial accounts, reports, photographs, audio recordings, films, and an endless variety of other materials in various media and formats that document their activities through time.

When a body of archival material comes to the SFU Archives, we typically keep it together under the name of the organization or person that created it. That is to say, by its *provenance*.

An archivist arranges the records according to the *original order* in which the creator kept them. Provenance and original order preserve the *evidential value* and *context of the records*. For example, if a letter dated 30 years ago is found with notes for a book published ten years later, a researcher might be able to deduce that the letter was used in the research for the book.

In SFU Archives you will find two types of archival accumulations. An *archival fonds* is made up of the records naturally created by a person or an organization in the course of day-to-day activities. A *collection* is an artificial assembly of materials brought together on a particular subject or theme. While useful, collections might not have the same evidential value as a fonds. Our holdings contain both fonds and collections.

## Using a finding aid

A finding aid describes a particular fonds or collection, including information about its creator, the types of records that comprise it, and its overall organization. Starting on the next page, this guide provides pointers to fonds and collections held by SFU Archives that relate to arts and culture in British Columbia. Make a note of the reference codes (e.g., F-10-4) for the entries that interest you, and bring this information with you when you visit the Archives.

For access to our entire catalogue of archival finding aids, visit our website at **www.sfu.ca/archives**. Here you will find more tools to narrow or expand your search, including filters that identify specific media held by the Archives (e.g. graphic materials, moving images, sound recordings, etc.) and records indexed by other subjects (e.g. labour, politics, women, etc.).

# Gaining access to the holdings

Visit the SFU Archives at Room 0400 in the Maggie Benston Student Services Centre. On your first visit, we will register you as a researcher. You must use the materials on-site, so allow time to take notes by hand or by laptop computer. Archival staff can perform limited reproduction services for a fee.

Researchers should be aware that access restrictions may apply to some of our records. Please see page 19 for more information.

We are open Tuesday to Friday from 9:00 to 12:30 and 1:30 to 4:00. Hours are subject to change so it's a good idea to make an appointment or check with us before you come.



**PUB** 

Founded in 1971, originally as the Independent Publishers Association (IPA), the ACP promotes the interests of the Canadian book publishing industry, including the writing, publishing, distribution, and promotion of books written by Canadian authors.

## Bennett, W.A.C., 1909-1981

R/TV

W.A.C. (William Andrew Cecil) Bennett (1900-1979) was a businessman, politician, and Premier of British Columbia from 1952-1972.

Audio recordings presented to or regarding W.A.C. Bennett. Items were produced primarily by radio stations, although some were created by private citizens.

Kate Braid is a Vancouver poet, author, carpenter, trade unionist, and educator. Her writings have appeared in many journals and anthologies, and have been broadcast on radio and television.

## Dunn, Margo, 1968-1993

**PUB** 

Margo Dunn – actor, writer, feminist and owner of Ariel Books – has been an active force in the Vancouver women's movement since 1966.

Ariel Books first opened in 1974 as a private business focusing on books about women's spirituality, but switched to collective ownership and a more general feminist bookstore format around 1975. Ariel Books specialized in books for women in such areas as feminist theory, politics, lesbian issues, violence against women, assertiveness, psychology, parenting, birth and midwifery, fiction and the like. Ariel Books also hosted readings by popular feminist writers, and acted as an essential resource for Vancouver women.

Records relating to Simon Fraser University's broadcasting relationship with Seattle-based KCTS/9, including co-production activities and the establishment of a broadcasting centre at the University. Day to day operational matters between KCTS/9 and SFU were conducted through the Office of the Dean of Continuing Studies. Matters of policy relating to the contractual agreement between KCTS/9 and SFU was the responsibility of the Office of the President.

**PUB** 

The Pacific Women's Graphic Arts Cooperative, in co-operation with Press Gang Publishers (a feminist press in Vancouver), produced *Makara* magazine from 1975 to 1978. The magazine was billed as "The Canadian magazine by women for people," and sought to explore alternatives to traditional journal structures while working towards positive social change. *Makara* was a general interest magazine, containing fiction, articles, interviews and dialogue, features, and a children's section.

# Press Gang Printers, 1970-1993

**PUB** 

Press Gang Printers was a feminist printing collective operating in Vancouver from 1970 to 1993. Its clients were primarily local feminist, radical, activist and community groups, and, especially in the early years, it often printed material that mainstream shops would not accept. Press Gang Printers and Press Gang Publishers (see below) were originally a single collective, but split into two distinct legal and corporate entities in 1989.

## Press Gang Publishers, 1975-2002

**PUB** 

Press Gang Publishers was a feminist printing press publishing quality trade paperback books – fiction, non-fiction, poetry and art – primarily by Canadian women authors and artists. Their non-fiction books addressed such social issues as the treatment of women by the mental health system, recovery from childhood sexual abuse, lesbian identity, homophobia and censorship, and women in conflict with the criminal justice system. Press Gang authors won numerous awards for their work.

## Smythe, Dallas, 1913-1999

R/TV PUB FILM

Dallas Walker Smythe was an economist and civil servant for the United States government and a university communications professor in both the United States and Canada. The primary focus of his research was television, including its content, effects on family life, and portrayal of reality. He also studied the mass media and its influence on public opinion. With the development of satellite communication, he studied the effects of this new technology on international communications.

Mark L. Winston is a professor of Biological Sciences at Simon Fraser University who is known for his research in apiculture - the management and study of honey bees, and his writing about science, nature, and environmental issues.

## Women's Bookstore, 1937-1997

**PUB** 

The Vancouver Women's Bookstore opened on July 16, 1973, making available women's movement literature such as underground papers, literary magazines, pamphlets, and books that portrayed women as intelligent, strong, equal, and creative human beings. In addition, the bookstore also functioned as a centre where women could meet to read, discuss issues, and plan rallies, marches and demonstrations.

## Cole, Doug, 1947-1995

**VART** 

Dr. Douglas Cole was a Professor of History at Simon Fraser University from 1966 to 1997. His teaching and research interests centred on Canada: specifically, on the history of Canadian art, anthropology, and Indian–White relations. He was an active member of the university community, serving on a number of committees and as president of the Faculty Association from 1986 to 1988.

Robert Harrison became a registered architect in 1954, and became the Registrar of the Architectural Institute of British Columbia in 1961. Later, Harrison was made Chair of the Institute's Examining Board (circa 1964). In 1963, Harrison submitted an entry to the contest to design Simon Fraser University. His design finished in fourth place. According to the contest parameters, the top five winners would each be given a contract to build a section of the campus in line with the winner's overall design. Harrison was responsible for designing the library and the administration building. He also made alterations to the Academic Quadrangle, designed later additions to the library, and made alterations to other buildings at Simon Fraser University.

#### Iredale, W. Randle, 1964-1978

**ARCH** 

Iredale received a degree in architecture from the University of British Columbia in 1955. He went to work for McCarter & Nairne until he was registered in 1957. He had his own practice from 1957 to 1959, and then formed a partnership with William R. Rhone. In 1963, Rhone and Iredale submitted an entry to the contest to design Simon Fraser University. Their design finished in second place. According to the contest parameters, the top five winners would each be given a contract to build a section of the campus in line with the winner's overall design. Rhone and Iredale chose the Science Complex.

#### Kiss, Zoltan, circa 1965-1981

ARCH

Zoltan S. Kiss attended the University of British Columbia where he completed a degree in architecture in 1951. Kiss worked for Thompson Berwick Pratt from 1953 to 1962. In 1963, Kiss submitted an entry to the contest to design Simon Fraser University. His design finished in third place. According to contest parameters, the top five winners would each be given a contract to build a section of the campus in line with the winner's overall design. Kiss chose the Academic Quadrangle, and incorporated his own ideas and innovations with Arthur Erickson and Geoffrey Massey's (the contest winners) concept. His other contributions to the architecture of Simon Fraser University include the President's house, student residences, and the pub.

A few months after the unveiling of the monument, *Marker of Change*, by artist Beth Alber in Thornton Park in Vancouver on December 6, 1997, the Project became inactive.

# Halpern, Ida, 1900-1990

MUS

Ida Ruhdšrfer Halpern (1916-1989), was a noted ethnomusicologist. She earned a doctorate in music from the University of Vienna and taught music history at the University of Shanghai. She moved to Vancouver, in 1939, with her husband, George. She taught music lessons in the family home and also lectured in music appreciation and later in ethnomusicology at UBC. In 1947, she began recording the music of First Nations peoples of the Pacific Northwest. In 1948, she helped found, and was first president of, the Friends of Chamber Music in Vancouver. Ida wrote numerous articles and a few books on First Nations music, and also published some sound recordings.

The bulk of Ida Halpern's professional papers are in the Provincial Archives of British Columbia. Records in the SFU Archives include inventories of her papers at that repository as well as records relating to a few professional and community activities. The correspondence is mainly personal, from friends or relatives, or related to Ida Halpern's volunteer efforts to promote music appreciation in Vancouver through various community groups. These groups included the Vancouver Women's Musical Club, Friends of Chamber Music, Festival Concert Society, and the Metropolitan Opera National Council (for regional auditions). There is some correspondence regarding her work for UBC Extension, *The Province* newspaper, CBC Radio, and Folkways records.

### Sons of Scotland Benevolent Association, 1895-1998

Organized in Toronto on June 27, 1876, the Sons of Scotland Benevolent Association is a fraternal association of Scottish people, their spouses, and their descendants in Canada. Its functions are to "preserve and promote Scottish heritage and culture in Canada" by maintaining Scottish historical, literary, and musical traditions, and to promote among its members a feeling of community and comradery.

# Women's Cultural Exchange, 1976-1977

The Women's Cultural Exchange was incorporated under the Societies Act in October 1976. Its objectives were to promote an appreciation of women involved in cultural endeavors in the community; to establish a common space for women who wish to share and exchange their skills, arts and resources in a congenial setting; to facilitate self-help through skill-building workshops, meetings and other educational activities; and, to further communication in order to develop a more cohesive women's community. 


Illustration from invitation to opening of SFU Museum of Archaeology and Ethnology, Saturday, December 15, 1979.

#### Shrum, Gordon, 1922-1989



# Appendix A

#### **Access Restrictions**

Researchers should be aware that access restrictions may apply to many of the records described in this Guide. Restrictions can arise from several sources:

- University records are subject to BC's *Freedom of Information and Protection of Privacy Act*; this requires restrictions on access to third-party personal information and some confidential information.
- Creators of non-SFU records sometimes negotiate time-limited access restrictions on the materials they donate to the Archives.
- The Archives handles the records of non-SFU organizations in accordance with the standards of BC's *Personal Information Protection Act*, which applies to all organizations that are not public bodies; access to personal information in these records may be restricted.

Each finding aid includes file and/or item lists. The lists indicate the access status of each file or item:

• Open	The	file	1tem	nas	been	reviewed;	no	access	restrictions	apply.

- **Restricted in whole** The file/item cannot be accessed under routine procedures; access may be possible under the terms of a Research Agreement.
- **Restricted in part**Restrictions apply only to one or a few documents in the file; researchers can routinely access the remainder of the file (minus the restricted documents); access to the entire file may be possible under the terms of a Research Agreement.
- **Pending review** Access status is not yet determined; an archivist must review the file/item before providing access and, as an outcome of the review, restrictions may apply.

A large proportion of the SFU Archives' holdings remain "pending review". Researchers should be aware that reviews for access may take time and they should factor that into their research planning.

## **Research Agreements**

In some circumstances, Research Agreements may be a feasible method of accessing restricted material. A Research Agreement allows the Archives to disclose records containing personal information to a researcher as long as certain terms and conditions are met to protect the privacy of the individuals identified in the records. # Appendix B

# Defining "Arts and Culture"

The SFU Archives holds a breadth of material relating to the provincial arts and culture sector. As a means of defining the scope of this sector, reference was made to the International Classification of Nonprofit Organizations (ICNPO). While the material covered by this guide is not restricted to just nonprofit organizational records, but also includes the personal papers of individuals as well as some university records, the ICNPO definition provides a useful starting point for interpreting or classifying the varied activities and pursuits that fall within the broad rubric of "arts and culture". The ICNPO describes the arts and culture sector in the following way:

This category includes organizations and activities in general and specialized fields of arts and culture, including media and communications; visual arts, architecture and ceramic arts; performing arts; historical, literary and humanistic societies; and museums, zoos and aquariums.

This classification scheme should not be considered definitive or scientific, but instead as just one way of grouping the varied records we hold and that relate in some way to the theme of arts and culture. In addition, many of the records cited in this guide could be construed as relating to many subjects or themes besides arts and culture. We hope that this guide provides a useful starting point to researchers interested in the arts and culture sector.
