This Inspection Report (IR) has been issued to document the employer's progress towards compliance with the orders issued in IR202118282055A. See IR202118282055A for the background information.

On March 18, 2022, the employer representative sent an electronic copy of an indoor air quality (IAQ) assessment that was conducted in the South Sciences Building (SSB), Technology and Science Complex 1 (TASC1), and Technology and Science Complex 2 (TASC2) January 21, 2022, February 8, 2022, February 18, 2022, and March 1, 2022:

"952_R03_SFU_IAQ_Assessment (TASC1-TASC2-SSB) FINAL_V3 (March 9, 2022)", dated March 16, 2022

Based on the above referenced IAQ assessment, orders #1 and #2 have been complied.

On April 13, 2022, I spoke to the employer representative by phone. The employer representative stated that the EHS Department has not received any odour complaints since approximately mid-January 2022. Start ups and shut downs of the Corix biomass plant have occurred between mid-January 2022 and today, but have not resulted in any odour complaints. The employer representative stated that they will continue to check in regularly with the workers in the affected buildings to verify that there are no additional odour complaints.

The outdoor concentrations were noted in the above referenced IAQ assessment to be between 416 and 440 parts per million (ppm). Therefore, based on section 4.79(2)(a), indoor concentrations must be less than 1,064 and 1,090 ppm.

Th above referenced IAQ assessment included spot measurements of carbon dioxide (CO2) in several locations throughout SSC, TASC1, and TASC2; indoor concentrations of CO2 were found to be significantly less than 1,000 ppm.

Based on the above referenced IAQ assessment, this order has been complied.

Initiating order:

<u>Dec 09, 2021</u> - An employer representative stated that workers began reporting indoor air quality ("IAQ") concerns as of October 2020. The employer retained two separate third-party consultants to conduct IAQ investigations as follows:

- An initial IAQ investigation was conducted from March 11, 2021 until April 6, 2021 ("SFU Air Quality Screen Measurements", April 27, 2021).
- A subsequent IAQ investigation was conducted from September 17, 2021 until September 27, 2021 ("Corix Biomass Burner SFU Burnaby Campus", October 15, 2021).

Neither of the IAQ investigations include an assessment of the ventilation rate or identify whether the carbon dioxide levels within the buildings are less than 650 ppm above the ambient outdoor levels.

This is in contravention of the Occupational Health and Safety Regulation Section 4.79(2)(a).

An air quality investigation must include assessment of the ventilation rate, unless the indoor carbon dioxide level is less than 650 ppm above ambient outdoor levels.

Note: in Subsection (2)(a) carbon dioxide is considered a marker indicator of sufficient outdoor air, not as a toxic air contaminant for which the exposure limit in Table 5-4 would apply. Normally, ambient levels are approximately 350 ppm, but may be higher in locations such as urban areas or during weather conditions such as inversions. Ambient levels may be assumed to be 350 ppm unless sampling establishes otherwise.

Measures to Ensure Compliance:

The employer must provide this Officer a copy of the IAQ investigation by January 28, 2022.

- A walk through inspection was conducted of the HVAC system in SSB, TASC1, and TASC2 was completed on January 21, 2022. Additional, drawings were reviewed to identify any potential contaminant sources.
- No potential contaminant sources were identified by the inspection of the HVAC system.
- The HVAC system appeared to be clean and in good working order, supplying all areas of the buildings assessed with an
 adequate supply of conditioned air and fresh outside air.
- Many air handling units had the current filters replaced with charcoal-coated filters.

Based on the above referenced IAQ assessment as well as the documents provided on January 28, 2022, this order has been complied.
